## INTRODUCTION

### ***What is a Victorian Purchasing Guide?***

The Victorian Purchasing Guide provides information for use by Registered Training Organisations (RTOs) in the provision of Victorian government subsidised training.

Specifically the Victorian Purchasing Guide provides the following information related to the delivery of nationally endorsed Training Packages in Victoria:

- The nominal hour range (minimum-maximum) available for each qualification.
- Nominal hours for each unit of competency within the Training Package.
- Sample Training Programs

### ***Registration***

RTOs must be registered by either the Victorian Registration and Qualifications Authority (VRQA) or the Australian Skills Qualification Authority (ASQA) regulatory body to be eligible to issue qualifications and statements of attainment under the Australian Quality Framework (AQF).

The VRQA is the regulatory authority for Victoria that registers VET training organisations who provide courses to domestic students only and who only offer training in Victoria.

To register to provide training to international students and in other Australian states and territories you will need to apply with ASQA.

<b>Qualification Code</b>	RGR10108	
<b>Description</b>	Appropriate as a pre-employment program for students in schools contemplating employment in the entry level occupation of Stablehand. Employees work in a thoroughbred or harness racing stable assisting with the care of individual horses as well as contributing to a safe, clean and hygienic environment. Appropriate for trainee stablehands who work under constant supervision with horses that are well-educated, tractable and docile. Driving or riding skills can be acquired through optional electives.	
<b>Notes</b>	RGR08 does not allow for any variation on the qualification structure for RGR10108. The relevant elective must be completed if seeking riding or driving skills.

The stablehand works under the direction of a trainer or stable supervisor but is also able to act autonomously in certain situations requiring solutions to a limited range of problems or working as part of a team.
