1. Key Dates

Final Booking Date is Friday 3 May 2024. Final Change Date is Friday 26 April 2024.

Final Cancellation Date is Friday 19 April 2024.

2. Booking

After registering a group of students to attend the Event via the Booking Form, the School Contact will receive a confirmation email confirming the day and time registered. All bookings must be made by the Final Booking Date.

3. Booking Changes

If the school wishes to change any part of the booking including attendee numbers and staff contacts, the School Contact must email <u>school.industry.event@education.vic.gov.au</u> by the Final Change Date.

4. Changes / Cancellation by the Department

The Department of Education (Department) reserves the right to suspend, postpone, vary (including holding an online Event) and/or cancel the Event, or any part of it, at any time and without prior notice, in which schools and attendees will not be entitled to claim compensation in any form. In the event of cancellation, the Department will do its best to arrange an alternative date and/or venue for the Event.

5. Cancellation by School

If a school wishes to cancel a booking, the School Contact must notify by email <u>school.industry.event@education.vic.gov.au</u> by the Final Cancellation Date.

6. Consent

Where a student in the registered group is under 18 years of age at the time of registration, written consent on behalf of the student must be obtained from a parent/guardian of the school.

7. Photo Consent

Attendance at the Event is a school excursion and consent for photographing and videoing students will be required. A consent form will be sent in a separate email shortly after booking. The School Contact is to distribute, collect and store all completed forms. The School Contact and/or teacher accompanying students to the Event must advise event registration staff upon check-in, which students are unable to be photographed/videoed.
