APRIL 2020 MEETING

The April meeting was attended by the following appointed members or their delegate:

CROSS-SECTOR RESPONSE TO COVID-19

Council acknowledged the unprecedented challenge presented by the COVID-19 pandemic and commended the collaboration across school sectors in response to the situation. Council further recognised the uncertainty facing schools and students, especially for schools still recovering from bushfires. Council affirmed the priorities of ensuring student health and wellbeing and supporting learning continuity through this difficult time.

Key issues that the three sectors are working collaboratively to address include:

- provision of senior secondary education including VCE and VCAL
- providing support to international students and students without internet access, and
- onsite provision for vulnerable students and children of essential service workers.

Council committed to continuing communication and collaboration to ensure a consistent response across all sectors. Processes are in place to ensure that regular dialogue continues between the school sectors and that key issues are responded to effectively.

BUSHFIRE RECOVERY

Providing support for schools, families and communities affected by bushfires remains a key priority for both the government and non-government school sectors.

Progress has been made to support schools impacted by bushfires, with the initial response transitioning to work on long-term recovery with a focus on addressing specific needs of local communities through self-determination and the establishment of community hubs.

Additional supports specific to each individual community continue to be rolled out on a regional basis. An update on individual recovery programs being implemented will be presented to Council at the July 2020 meeting.

COUNCIL PRIORITIES AND FORWARD AGENDA FOR 2020

Council reaffirmed its continued focus on its <u>priority work areas</u> agreed to in 2019.
