



# 2010 Early Childhood Community Profile

## Summary sheet for the Shire of Hindmarsh

### Local demographics for young children aged 0 to 8 years and their families.<sup>1</sup>

- There were 69 births notified to the local Maternal and Child Health services in Hindmarsh during 2008-09. This represents an increase of 15.9 per cent since 2006-07 and a decrease of 4.2 per cent since 2000-01. This compares to an increase in birth notifications across Victoria of 2.3 per cent since 2006-07 and 18.6 per cent since 2000-01.
- At 30 June 2008, there was an estimated 6,179 people residing in Hindmarsh. Of these, 601 were aged between 0 to 8 years, representing 9.7 per cent of Hindmarsh's total population.
- The population aged 0 to 8 years in Hindmarsh is projected to decrease by 29.8 per cent by 2026, while the total population in Hindmarsh is expected to decrease by 17.8 per cent over this period.
- Using the Index of Relative Socioeconomic Disadvantage, Hindmarsh was ranked 10 out of 79 LGAs in Victoria. A rank of 1 was assigned to the most disadvantaged LGA in Victoria.
- Of the 380 families with children aged between 0 and 8 years in Hindmarsh, 83.7 per cent were couple families and 16.3 per cent were one parent families.
- There were 64 Aboriginal persons in Hindmarsh, representing 1.1 per cent of the total population. 15.6 per cent of the Aboriginal population in Hindmarsh were aged 0 to 8 years.

### Health, learning, wellbeing, development and safety indicators for children in the local area.<sup>2</sup>

- 33.8 per cent of infants in Hindmarsh were fully breastfed at 3 months and 26.2 per cent of infants were fully breastfed at 6 months.
- 96.4 per cent of children in Hindmarsh were fully immunised at 12-<15 months, 96.6 per cent were fully immunised at 24-<27 months and 86.1 per cent were fully immunised at 60-<63 months.
- 70 Prep children were surveyed in the Australian Early Development Index (AEDI) in Hindmarsh during 2009. Of these, 29.4 per cent were vulnerable on one or more domains and 20.6 per cent were vulnerable on two or more domains.
- In 2008, 61.3% students enrolled in government schools in Hindmarsh were achieving a reading accuracy score of 90% or more on Level 5 texts, 83.9% of Year 1 students were reading Level 15 texts with over 90% accuracy and 86.5% of Year 2 students were achieving 90% accuracy or higher on Level 20 texts.

### Families in Hindmarsh.

- Based on the 2009 VCHWS survey results, 48.2% of children aged 6 months to 12 years were reported to have been read to almost every day in the Grampians region. This was similar to the proportion of children being read to almost every day across Victoria (48.3%).
- Based on the 2009 VCHWS, 3.3% of main carer's of children aged 0 to 12 years in the Grampians region were classified as being of high risk of psychological distress. This proportion was lower, but not significantly different to that reported across Victoria (3.7%).
- In 2008 - 2009, the number of substantiated cases of child abuse in Hindmarsh were suppressed due to small numbers and therefore a rate of child abuse substantiations could not be derived. This compares to a rate of 7.0 per 1000 children across Victoria.
- Over 2007 - 2008, the number of families with children aged 0 to 8 years in Hindmarsh who remained in public housing 12 months or more after initial allocation was suppressed due to small numbers.



### Indicators relating to the local community.<sup>3</sup>

- 96.5% of children aged 0 to 12 years in the Grampians region were from households who reported being able to get support from friends, family and neighbours in times of crisis/need. This proportion was higher than, but not significantly different to the proportion reported across Victoria (95.2%).
- 97.3% of parents of children aged 0 to 12 years in the Grampians region reported that having someone they could turn to for advice when having problems. This proportion was similar to the proportion reported across Victoria (97.1%).
- 97.2% of children aged 0 to 12 years in the Grampians region were from households where the parent or guardian agreed that their neighbourhood was safe. This proportion was higher than, but not significantly different to the proportion reported across Victoria (95.1%).

### Supports and services in Hindmarsh.

- During 2008 - 2009, there were 6.9 hospital separations for gastroenteritis per 1,000 children aged 0 to 1 in Hindmarsh. This is less than the rate of hospital separations in Victoria (9.5 per 1,000 children aged under 1) .
- In 2008 - 2009, 104.3 per cent of infants in Hindmarsh received a home consultation visit and 57.1 per cent of children in Hindmarsh attended the 3.5 year key ages and stages visit.
- The kindergarten participation rate in Hindmarsh during 2009 was 70.9%. This was less than the kindergarten participation rate in Victoria (92.7%).
- Prep students attending government schools in Hindmarsh were absent for an average 18.0 days over the 2009 school year. Year 1 students were absent for an average 15.1 days and Year 2 students were absent for an average 14.4 days over the 2009 school year.

### Early childhood services for families in Hindmarsh.

- As at August 2010, there were 7 primary school education providers in Hindmarsh - 4 government, 1 Catholic and 2 independent.
- In 2009, there were 4 funded kindergarten programs in Hindmarsh. Of these, none were kindergarten programs located within a long day care setting.
- As at 22 July 2010, Hindmarsh had 1 multi-service Children's Centres completed or under development, funded by state and local government. These were:
