

# Children's services regulatory fees

In line with the provisions of the Monetary Units Act 2004 all fees are expressed in fee units. Fees are automatically indexed each year on 1 July. The value of a fee unit each year is published by the Treasurer.

As the *Children's Services Act 1996* (CS Act) and Children's Services Regulations 2020 (CS Regulations) do not express fees in dollars, the tables below convert the fee units to dollar amounts.

There is no GST payable on fees. The fees in this table are effective from 1 July 2023.
