

# **Maternal & Child Health Services Annual Report**

2015-2016 Statewide

Note: In 2015-16 a new record system was introduced for a number of Maternal & Child Health service providers.

Difficulties in transitioning to this system are likely to have led to data showing:

- incorrect breastfeeding numbers and rates;
- higher than expected enrolment numbers;
- lower than expected participation rates for Key Ages and Stages (KAS) consultations;
- lower than expected counts of flexible capacity activities and referrals.

Other data may also be affected.

#### As such:

- statewide breastfeeding data has been omitted from this report.
- caution should be taken when using this report data for time series analysis.
