


Acknowledgement of Traditional Owners

What is the Workforce Skill Set Fund (WSSF)?

The Fund is designed to:

- strengthen the relationship between industry and TAFEs to ensure delivery of skill sets which provide quality workforce training and skill development
- test skill set offerings to upskill/reskill workforces, building an evidence base to support the development of the Skills First Skill Sets policy
- improve the flexibility and responsiveness of the training and TAFE system in meeting industry skill-needs and enterprise training requirements
- contribute to employer confidence/investment and broader economic recovery efforts

What does the program fund



- 1. Delivery of existing skill sets
- Development and delivery of new skill sets from existing accredited units
- 3. Development and delivery of new skill sets not met by existing accredited training units

Stream 1: (50% of total funding): \$6,500,000 Stream 2: (30% of total funding): \$3,900,000 Stream 3: (20% of total funding): \$2,600,000

^{*}Applications seeking funding for non-accredited elements under Stream 3 will be assessed on suitability for potential to progress to formal accreditation.

Partnerships



A key objective of the fund is to::

- Promote dynamic partnerships between industry and training providers
- All streams must demonstrate a partnership with an industry partner, including a co-contribution
- increasing investment by industry through cocontribution (in-kind or financial)

Encouraging a broader cultural shift in training and workforce development.

There are two potential roles parties may have in a funded project – Lead or Partner.

Multiple applications can be submitted by the lead for each Skill Set, aligned to each individual partner.

Who can apply?




- Stream 1 proposals will be limited to TAFEs.
- Stream 2 & 3 Victorian training providers that hold a current Skills First VET Funding Contract are eligible to apply.

Application Assessment Criteria

- Industry needs and impact / Partnerships— 30%
- Training delivery capability, capacity and approach 30%
- Student attraction and retention 15%
- Cost to deliver, value for money and sustainability— 15%
- Evaluation— 10%



Budgets



- Provide a budget breakdown including any expected forms of revenue or co-contribution
- Provide detailed evidence of costs associated with course delivery
- Indicate how the course could remain sustainable beyond the initial WSSF funding
- Outline how the costs provide value for money for the Victorian public

What the program DOES NOT fund



The following are not eligible for funding:

- business as usual costs included in the 'course overheads fees'
- proposals that create an ongoing liability for Government
- proposals that are deemed more suitable for consideration under the Department's other funding programs e.g. Regional and Specialist Training fund (RSTF) or Workforce Training Innovation Fund (WTIF)

Lessons Learnt



- Committed Partnerships clearly defined roles & responsibilities
- 2. Skilled program and project managers
- **3. Structured** and **phased** rollout, including **sign-off** on milestones from partners
- **4. Effective** and comprehensive **communication** strategies transparency is key
- 5. Appropriate and Relevant Evaluation Strategies
- 6. Ability to pivot, adapt and be responsive

Next Steps



- 1. Visit the Workforce Skill Set Fund website page
- 2. Lodge your interest in developing a grant funding application by completing the online EOI Form
- 3. A Department representative will contact you within 5 business days to discuss your proposal.
- 4. Should the EOI be deemed appropriate, a link to the online grant application form will be sent to you
- 5. Complete the online WSSF application and submit to the Department's online portal
- 6. On submission of your online application, you will receive an automated response to acknowledge receipt of your application
- 7. If you proceed to lodge an application, remember that applications received by 31 November will be assessed by the 31 January 2022
- 8. Applications are rolling and can be lodged at any time
